Please note: According to the MSS regulations, a horse may not start in these events unless it has had at least one satisfactory charted performance line. A satisfactory charted performance line is one performed behind a starting gate in a qualifying or purse event and showing the minimum performance time without a break within 30 days of the event in which he starts. Time trials, official workouts and uncharted fair lines do not qualify for the above standards and cannot be used to meet the qualifications. Also, these satisfactory charted performance lines cannot include any type of break, including interference or equipment breaks. No time allowances are given for half-mile tracks, "off" tracks or any other reason. **Absolutely no entries will be accepted after the box closes!** Please make your entries early! **Declaration fees must be paid to the Race Secretary's office and checks made payable to "Maryland Standardbred Race Fund"**. We ask that you pay your declaration fees promptly and as far in advance as possible. We suggest that owners give their trainers a copy of this page and the attached list of eligibles.
