Time trials, official workouts and uncharted fair lines do not qualify for the above standards and cannot be used to meet the qualifications. No time allowances are given for half-mile tracks, "off" tracks or any other reason. **Absolutely no entries will be accepted after the box closes!** Please make your entries early! **Declaration fees must be paid to the Race Secretary's office and checks made payable to "Ocean Downs".** We ask that you pay your declaration fees promptly and as far in advance as possible. We suggest that owners give their trainers a copy of this page and the attached list of eligibles. This will ensure that all horses meet the eligibility and declaration deadlines.
